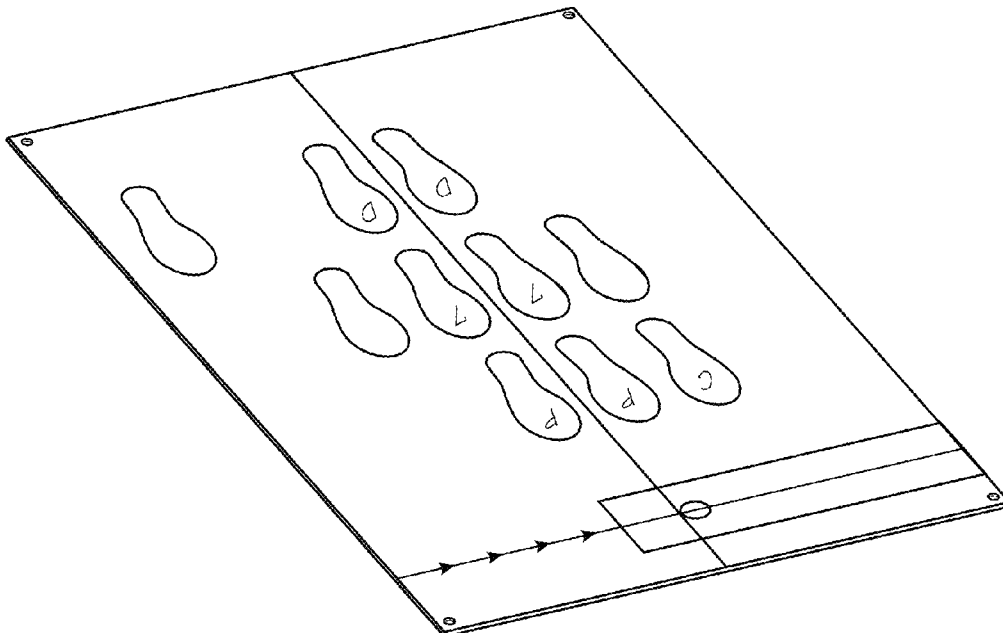

(57) **CLAIM**
The ornamental design for an alignment training mat for golf, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an alignment training mat for golf showing our new design; and, FIG. 2 is a top plan view thereof.

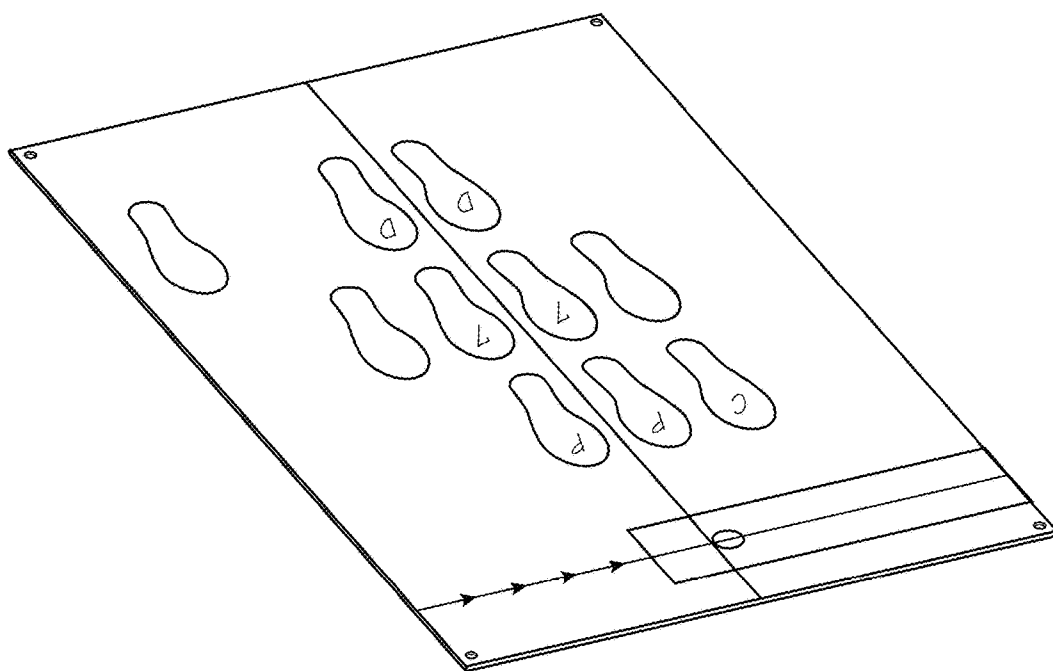

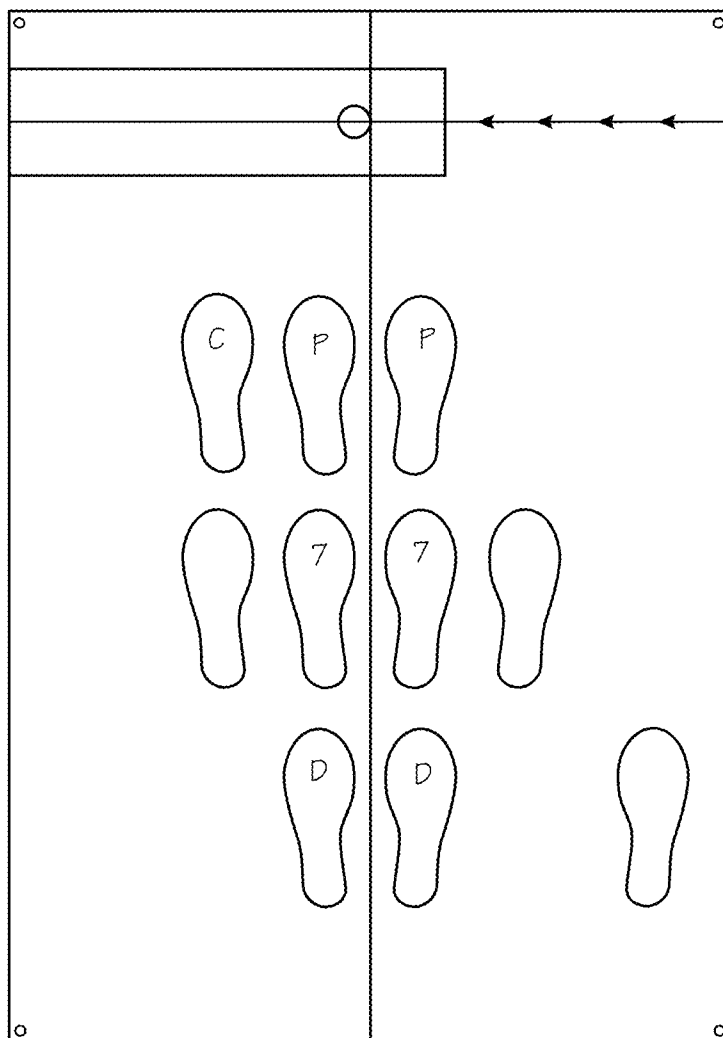
